

THIS DEED, made and entered into on this 20th day of September, 1977, by and between CLAUDIE FULLER and BLANCHE FULLER, husband and wife, parties of the first part, and JOHNNIE BOYD, party of the second part.

WITNESSETH:

That for and in consideration of the exchange of land, the parties of the first part do hereby grant, bargain, sell and convey to Johnnie Boyd, with covenants of General Warranty and English Covenants of Title, all that certain tract or parcel of land lying and being on the waters of Lick Creek in Dickenson County, Virginia, and being more particularly bounded and described as follows:

BEGINNING on a beech tree in a hollow below a field; thence N E to a stake on a point; thence up said point to a big white oak stump; thence S E to a stake in a field; thence S E to a stake in the Haburn line; thence S W to the top of the point; thence with the fence to a maple; thence N to a maple; thence N W to a stake on a point; thence W with a fence to the BEGINNING, containing 19 acres, more or less, and being the same land conveyed by K. B. Owens and Laura Owens, his wife, to Claudie Lester Fuller and Blanche Fuller, his wife, by deed dated April 9, 1974 and of record in Deed Book 165, Page 001 of the Clerk's Office of Dickenson County, Virginia.

There is expected from this conveyance the following two tracts of land:

Tract No. 1 BEGINNING at a stake in a hollow, a common corner to tract number one and tract number two of the deed from Claudie Fuller and Blanche Fuller to Larry Wayne Boyd and Michael Lee Boyd, dated September 20, 1977, thence S 16° 08' W 327.59 feet along the dividing line of tract number one and tract number two of the deed to a nail in a maple in fence line; thence N 67° 01' W 230.65 feet to a nail in double maple, thence N 35° 27' W 103.97 feet to a nail in a maple; thence N 36° 43' W 157.74 feet to a nail in a beech in hollow; thence N 87° 06' E 288.34 feet to a tack in a black walnut in a drain, thence S 89° 38' E 170.00 feet to the BEGINNING, containing 2.03 acres, more or less;

Tract No. 2 BEGINNING at a stake in a hollow, a common corner to tract number one and tract number two of the deed from Claudie Fuller and Blanche Fuller to Larry Wayne Boyd and Michael Lee Boyd, dated September 20, 1977; thence S 89° 38' E 101.55 feet to a nail in forked poplar on hillside; thence S 81° 41' E 233.66 feet to a stake up a hollow; thence S 40° 08' W 443.17 feet to a stake in fence line; thence 67° 01' W 150.00 feet to a nail in maple in fence line; thence S 16° 08' W 327.59 feet along the dividing line of tract number one and tract number two of the deed to the BEGINNING, containing 2.00 acres, more
