FINAL JUDGMENT OF DISSOLUTION
OF MARRIAGE

THIS CAUSE having come on to be heard for Final Hearing on October 2, 1981, and the Court having heard the testimony of the Petitioner and the Petitioner's witnesses and being otherwise fully advised in the premises find as follows:

1. That the marriage between the parties is irretrievably broken and should be dissolved.
2. That the parties have entered into a Property Settlement Agreement dated January 25, 1980, which is fair and equitable and should be ratified and approved.
3. That the Petitioner requests the restoration of her maiden name, FONTILLA ROBINSON.
4. That the Court has jurisdiction of the parties and the subject matter.

IT IS THEREFORE ORDERED AND ADJUDGED:

1. That the marriage between the parties is dissolved a vinculo matrimonii.
2. That the Property Settlement Agreement entered into by the parties on the 25th day of January, 1980 is fair and equitable and is therefore ratified, approved and confirmed and made a part of this final decree.
