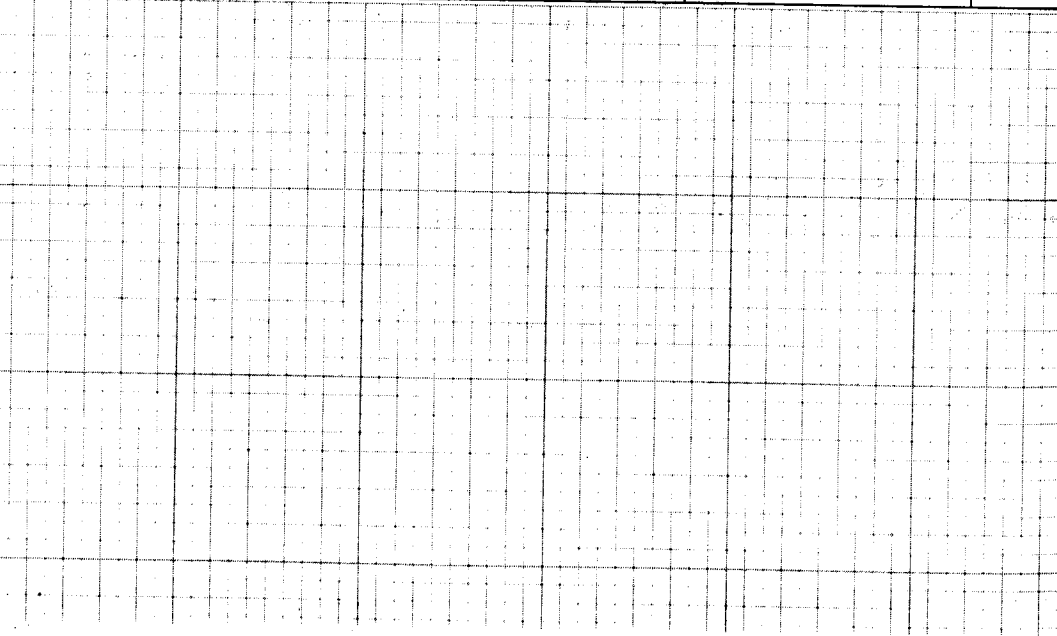

Last Will and Testament

OF

RACHEL L. HAMILTON


I, Rachel L. Hamilton, a resident of Dickenson County, Commonwealth of Virginia, being of full age and sound and disposing mind and memory, hereby make, publish and declare this to be my Last Will and Testament, and I hereby revoke any and all wills and codicils by me at any time heretofore made.

FIRST: I direct that all my just debts and funeral expenses be first paid as soon as practicable after my death.

SECOND: After the payment of my just debts and funeral expenses, I give, devise and bequeath all of my estate, real, personal and mixed, of every kind and nature whatsoever and where-soever situated to my two daughters, Nora Hamilton and Edna Hamilton, to the exclusion of all my other children, absolutely and in fee simple, in equal shares, and if either of them not be living at the time of my death, the share of such person shall go to her issue, per stirpes, but if there be no such issue living then the share of such person dying without issue shall be paid to the survivor.

neither Nora Hamilton nor Edna Hamilton shall be required to give any bond as such Executrix.
