Dear Mr. & Mrs. Sykes:

After doing the research on the property of Noah and Samantha Sykes, I found they purchased Lot 9 Block 7 on Mill Creek in Deed Book 55 page 420, on July 26, 1926. They later sold it to Edith Stallard on May 23, 1958. The property has since been sold several times and it now belongs to Alice McCoy. Her deed is recorded in Deed Book 269 page 284. There is a clear title to this property as through one of the sales it was posted on the Courthouse and published in newspapers that anyone having any interest in this property appear in court. The title was cleared at this court hearing.

Also, I found where Noah and Samantha Sykes purchased Lot 8 Block 9 in Deed Book 52 page 113. I cannot find where this property was ever sold.

If anyone pays the delinquent taxes on this property, we can abate $\frac{1}{2}$ of the taxes since one lot was sold in 1958. Please contact this office if you are interested in paying on Lot 8 Block 9.
